ORDER:

The Social Welfare (TW) Department has informed that, the Government have given 14.0 lakhs acres of land to 1,58,745 tribal beneficiaries inclusive of community rights over community lands under Recognition of Forest Rights (ROFR) Act, 2006. Among them individual rights were given to 1,56,740 beneficiaries over 4,53,749 lakhs acres. Under NREGS a massive land development is being taken up in these lands besides coffee and rubber plantations, roads and minor irrigations and food security projects. To monitor these projects at the state level it is proposed to create a Project Monitoring Unit with officers of the Level of Joint Director, Deputy Director and two others on contract basis. The annual financial commitment will be around Rs.20.00 lakhs and it is proposed to meet this expenditure from 4% of the estimated cost of the works Rs.942.42 crores which comes to Rs.37.69 crores.

2. Further, the Social Welfare (TW) Department has stated that, the Commissioner of Tribal Welfare, Hyderabad has proposed to constitute a State Level Project Monitoring Unit in TRICOR along with creation of following posts for an initial period of two (2) years and filling of these posts on deputation basis.
 - ✓ a. One (1) post of State Project Manager (NREGS) in the cadre of Joint Director to ensure proper planning, monitoring and execution of projects. (on deputation basis).
 - b. Three (3) posts of Deputy Project Managers in the cadre of Deputy Directors preferably from Agriculture / Horticulture / Agricultural Engineering / Civil Engineering / Forests etc. (on deputation basis).
 - c. One (1) Asst. Project Director with graduation in management from institutes of national reputation / NGOs on contract basis and
 - d. One (1) Data Processing Officer on contract basis.

3. Therefore, it has been proposed for Creation of one(1) post for Joint Director and (3) three posts of Deputy Director for establishment of State Level Project Monitoring Unit in TRICOR and filling up of these posts on deputation basis.

4. Government after careful examination of the matter hereby accord sanction for Creation of one (1) post for Joint Director and (3) three posts of Deputy Director for establishment of State Level Project Monitoring Unit in TRICOR and filling up of these posts on deputation basis in the scale of pay of Rs.27000-51760 and Rs.21820-48160 respectively.

5. The expenditure on this unit shall be met from administrative cost permitted by the department of Rural Development.

6. The Social Welfare (TW.Ser.II.1) Department shall take further necessary action accordingly.
