In the reference 1st & 2nd read above, the Commissioner of Tribal Welfare, TS, Hyderabad has sanctioned and released an amount of Rs.2,62,90,274/- (RUPEES TWO CRORE SIXTY TWO LAKHS NINETY THOUSAND AND TWO HUNDRED AND SEVENTY FOUR ONLY) 1st & 2nd Quarter to meet the expenditure (including Opening Balance) under HoA: 2225-02-MH 277-GH 25-SH (05) Educational Institutions 310/312 OGIA" from the BE provision 2020-21. Out of which an amount of Rs.1,97,89,912/- (RUPEES ONE CRORE NINETY SEVEN LAKHS EIGHTY NINE THOUSAND NINE HUNDRED AND TWELVE ONLY) incurred expenditure and there is a balance of Rs.65,00,362/- (RUPEES SIXTY FIVE LAKHS THREE HUNDRED AND SIXTY TWO ONLY).


