ORDER:

In the reference 1st read above, Government have communicated the AP Re-organization Act 2014 and the Corporations/PSUs need to be bifurcated between two states have been included under Schedule-IX of Act. Subsequently the Government asked to take action for Demerge of departments/Offices/societies which are not included schedule IX and X.

2. The Integrated Tribal Development Agency for Development of ST in Plain Areas, Hyderabad was registered under A.P. Societies Registration Act, 2001 on 17-12-2009 vide Registration No.788/2009 and subsequently bye-laws were also registered on 16-6-2010 before the Registrar of Societies, Hyderabad (South) as Document No.256/2010.

3. In the reference 2nd read above, the Chairman, ITDA for Development of STs in Plain Areas, Hyderabad has informed that the Governing Body of ITDA for Development of STs in Plain Areas and have passed a Special Resolutions on 28.05.2014 as detailed below:

1. Resolved to permit the division of the Integrated Tribal Development Agency (ITDA) for Development of Scheduled Tribes (STs) in Plain Areas into two ITDAs for Andhra Pradesh (Residuary) State & Telangana State as per the provisions of A.P State Re-Organization Act, 2014.
2. Resolved to authorize the Project Officer, ITDA, Plain Areas, to Re-register the new ITDAs, prepare Bye-Laws etc., required for both the ITDAs i.e., Integrated Tribal Development Agency (ITDA) for Development of STs in Plain Areas for Andhra Pradesh (Residuary) State & Integrated Tribal Development Agency (ITDA) for Development of STs in Plain Areas for Telangana State.

4. In the reference 3rd read above, the Commissioner of Tribal Welfare, Hyderabad / Chairman, ITDA, Plain Areas has requested the Government to permit the respective Project Officer, ITDA to register two (2) new ITDAs i.e., Integrated Tribal Development Agency (ITDA) for Development of STs in Plain Areas for Andhra Pradesh (Residuary) State & Integrated Tribal Development Agency (ITDA) for Development of STs in Plain Areas for Telangana State under Societies Registration Act and also permit to frame Memorandum of Association, Rules and Regulations and Bye-laws for the two ITDAs separately.

Government after careful examination of the proposal of the Commissioner of Tribal Welfare, Hyderabad / Chairman, ITDA, Plain Areas and in pursuance of the Resolutions of the Governing Body, hereby accord permission to the respective Project Officers for registration of new ITDAs viz., Integrated Tribal Development Agency (ITDA) for Development of STs in Plain Areas for Andhra Pradesh (Residuary) State & Integrated Tribal Development Agency (ITDA) for Development of STs in Plain Areas for Telangana State under Societies Registration Act and also to frame Memorandum of Association, Rules and Regulations and Bye-laws for the two Corporations separately.

6. The Commissioner of Tribal Welfare, Hyderabad / Chairman, ITDA, Plain Areas/ Project Officer, ITDA concerned shall take necessary action accordingly.
