ORDER:

The Government have accorded administrative sanction for establishment of ITDA for development of Scheduled Tribes in Plain Areas with headquarters at Hyderabad vide ref 1st cited above.

The Integrated Tribal Development Agency for Development of STs in Plain Areas, Hyderabad was registered under A.P.Societies Registration Act, 2001 on 17.12.2009 vide Registration No. 788/2009 and subsequently bye-laws were also registered on 16.06.2010 before the Registrar of Societies, Hyderabad (South) as Document No. 256/2010.

The jurisdiction of the ITDA is subject to the exclusion of areas included in ITDAs Adilabad, Asifabad, Nirmal, Mancherial, Warangal (Urban), Warangal (Rural), Jayashankar Bhupalapalli, Janagaon, Mulugu, Mahabubabad, Khammam and Bhadradri Kothagudem shall extend to the districts of Nizamabad, Kamareddy, Karimnagar, Rajanna Siricilla, Peddapalli, Jagitial, Hyderabad, Medak, Sangareddy, Siddipet, Rangareddy, Vikarabad, Medchal Malkajgiri, Nalgonda, Yadadri Bhongir, Suryapet, Mahabubnagar, Nagarkurnool, Jogulamba Gadwal, Wanaparthy and Narayanpet.

The mandate of the ITDA Plain Areas is to formulate appropriate plans for overall and integrated development of STs living in Plain Areas coordinating with line departments, district administration of the respective districts for implementation of various developmental and welfare programs intended for STs.

It is noticed that there is considerable delay in supply of Food provisions and Cosmetics for the Plain Area Districts by GCC. Most of the Plain area DTDOs are frequently complaining that the food provisions and Cosmetics are not being supplied in time by GCC in plain area Districts. It has been reported by GCC that the supply of Food provisions and Cosmetics to the plain area districts is being tagged to ITDA Eturunagaram & Utnoor. Eturunagaram & Utnoor divisions are not able to supply the food provisions in time and is also not able to monitor the supplies to plain area institutions.

Hence, the Commissioner Tribal Welfare and Managing Director GCC has decided to constitute a separate purchase committee for Plain Area ITDA for supply of food provisions and Cosmetics to the plain area TW Institutions with the composition on par with other ITDAs.
