ORDER:

In the reference 1st cited, the Commissioner of Tribal Welfare, TS, Hyderabad has sanctioned and released an amount of Rs.10,76,00,000/-(Rupees TEN CRORES SEVENTY SIX LAKHS ONLY) to meet the expenditure under the scheme HoA: "2225-02-MH 102-GH 12-SH (06) TCR & TI 310/312 Other Grant-in-Aid (Scheme/CSS)" from the BE provision 2020-21. Out of which an amount of Rs.8,98,00,000/-(RUPEES EIGHT CRORES NINETY EIGHT LAKHS ONLY) incurred expenditure and there is a balance of Rs.1,78,00,000/-(RUPEES ONE CRORE SEVENTY EIGHT LAKHS ONLY).

In the reference 2nd cited above, the Commissioner of Tribal Welfare, TS, Hyderabad has requested the Project Officer, ITDA (PA), TS, Hyderabad to release an amount of Rs.48,00,000/-(RUPEES FORTY EIGHT LAKHS ONLY) in favour of POs and DTDOs towards Geo-coordinates & Polygon mapping of RoFR ineligible claims to ITDAs and Districts out of the available budget from PD account of PO, ITDA(PA), TS, Hyderabad under HoA: 2225-02-MH 102-GH 12-SH TCR & TI 310/312 Other Grant-in-Aid (Scheme/CSS)".


