ITDA Plain Areas at Hyderabad is planning to cater to the Tribal Societies (Tribal Self Help Groups) and assist them in value addition units, which augments their livelihood on par with other ITDAs in the State.

It is proposed now to offer nutritional support to the STs of Plain areas as part to the Giri Poshan Project, in partnership with Women Development and Child Welfare Department, to benefit children (3-5 years), pregnant and lactating women and adolescent ST girls. This is proposed to be funded jointly by the Ministry of Tribal Affairs (MoTA) and the State Department of Women Development and Child Welfare, Govt. of Telangana.

In the ITDAs of Utnoor, Bhadrachalam and Eturnagaram, MSME value addition units to manufacture FSSAI certified 'Giri' branded Jowar-Upma, Multi Grain – Millet Upma, Sweet Multi grain Mix and Peanut Chikkis have already been established. These are formulated by ICRISAT and the products are supplied to both Giri-Poshana project areas and Tribal Welfare Ashram Schools, Hostels and Gurukulams with good consumer feedback.

It is learnt that there is a extruder snack machine that is presently unused at Telangana Foods factory at Nacharam, Hyderabad which will further augment the nutritional foods that TW Dept,. can make available under the Giriposhana project to targeted STs and to supply to TW Educational Institutions.

Hence it is requested to fix the rental charges of out sourcing the Extruder machine / unit of TS foods to enable this office to take necessary action for commencement of production on outsourcing basis at the earliest
